# 2 Minutes of last meeting

The minutes of the meeting held on 25<sup>th</sup> May 2023 previously circulated with the meeting notice were approved and signed. **Action: GOB to sign and forward to Clerk** 

# 3. Update on Developments since last meeting

GOB summarised recent developments. OxonCC has scheduled the HIF1 Planning Hearing for 17<sup>th</sup> July (1:00pm – 6:00pm) and 18<sup>th</sup> July (10:00am – 1:00pm).

The starting time was delayed until 1:00pm to allow people to attend the Pre-Inquiry Meeting called by the Inspector inquiring into the CPO for the HIF1 scheme. This effectively allows one day for HIF1 which is inadequate for such a large scheme.

The Case Officer Report has been published – 220 pages. Subject to the application first being called in to the Secretary of State whether they (Cllrs) wish to call it for their own determination, that the application is approved.

The election for Chair and Vice-Chair of the Planning & Regulation Committee for 2023-24 took place on 5<sup>th</sup> June with Cllr Geoff Saul and Cllr Richard Webber re-elected as Chair and Vice Chair respectively.

#### 4. Meeting with Barrister

RA outlined the meeting with Jack Smyth, Barrister No 5 Chambers. He spoke well and demonstrated his presentation skills but disappointingly had not read or assimilated all the material sent to him.

#### 5. Other Developments

The Grampian Condition was explained and request from Charlie Hopkins that we do a reconciliation of housing completions trajectory (VoWHDC & SODC). SCR to assist.

Due to the imminent Planning and Regulation Committee hearing, the noise issue was not discussed.
