### Culham: A415 Abingdon Road - proposed Sparrow Crossing & traffic calming – Consultation

Following years of lobbying by Culham Parish Council, Culham Bike Users Group, and more recently Olly Glover MP in conjunction with other County and District Councillors, I'm delighted to report that the consultation has opened [here](#).

The proposals, for which funding was approved by OxonCC Cabinet in October, are being put forward to help improve active travel routes & road safety in the area, especially for families cycling to Europa School from Culham. These include:

1. **'Sparrow' Crossing** as pictured above (a signal-controlled crossing for use by both pedestrians and pedal cyclists, with a separate cycle track parallel to the pedestrian crossing) – to be located approx 15 metres west of the signalised junction with Tollgate Road
2. **Side Road Entry Treatment** traffic calming feature – to be located at the junction with Thame Lane
3. **Shared-use path** – a short section of footway on Tollgate Road in advance of the new crossing will be widened to three metres and converted to a shared use footway/cycleway.

Improvements to street lighting at the junction, and the existing foot & cycle-path on the northern side will also be developed as part of the proposals

### **Last Full County Council on 10th February**

At the Full Council meeting, the Lib Dem budget was voted in. Of the opposition parties, only the Green Party managed to get their budget amendments accepted.

This was achieved by working with OxonCC officers about the possibilities of the mechanisms available and then talking directly with the Liberal Democrat administration and Cabinet about our ideas and why they are important. Thankfully they agreed with us.

This means that there will now be a dedicated fund (£900k) for footpaths, cycleways and pavements which we have long campaigned for. These facilities are normally funded from within the Highways budget and therefore typically compete with the road network.

We also guaranteed funding for community cohesion and public health focussed climate change adaptation and resilience.

### **Multi-agency operation targets anti-social parking and highway obstruction**

OxonCC, SODC, the DVLA and the DVSA, the Parish Councils and Thames Valley Police conducted a joint operation on the garage businesses in Pettiwell in Garsington and in Littleworth this February resulting in business closures, vehicle impoundings, waste management and scrap investigations, and arrests including one for modern slavery.
